About Dr. Edward F. Dow: Dr. Dow was a professor of government and head of the department of history and government at the University of Maine. He was also director of the annual New England Managers' Training Institute and aided in initiating a training school for Maine tax assessors. Dr. Dow was a member of a seven-man committee studying the Maine tax system as it affects local government. He was also a part of the Maine Municipal Advisory committee and part of the state YMCA committee which sponsored model state legislature. He coauthored *City Manager Government in Portland, Maine*, and was a contributor to numerous periodicals and encyclopedias.

Scholarship Purpose: For decades, Dr. Edward F. Dow was an author, an innovator, a mentor and a leader to Maine Public Administrators. The Dr. Edward F. Dow Student Scholarship Award is presented by the Maine Town City/County Managers Association (MTCMA) to honor and recognize Dr. Dow's lifelong accomplishments, exceptional career, and dedication to the Public Administration profession. The Dr. Edward F. Dow Award is presented annually to a person planning to study or currently studying Public Administration, civic leadership/community service or government. This person must clearly demonstrate noteworthy leadership skills during the course of his/her studies/career and show early participation in Public Administration work.

Should a high school senior be the recipient of this award, the award will be announced for his/her graduation and funds will be distributed with the submission of acceptable grades from the first semester of college.

Nominating Criteria

<u>Graduate</u>, <u>undergraduate</u>, <u>or high school seniors</u> may be nominated by the school or by publicly appointed or elected officials. In order to be considered for the award, the nominator must fill out the complete application and attach any typed relevant information that demonstrates the nominee's qualifications for the award.

The award criteria for the scholarship will be based on the following:

- a. The strength of the nomination. (see the attached nomination form)
- b. Nominee's degree of participation in the field of civic leadership, public administration, or community service. The dedication and commitment they have shown for these fields in relation to their experience. Any demonstrated and active participation in government administration and leadership.
- c. The likelihood the nominee will make a significant contribution to the fields of government administration and leadership.
- d. Student's grades achieved in the course work related to these fields. (Please attach student's unofficial transcripts).
- e. Any additional achievements related to their course of study.
